

General terms and conditions of use of the website Billetix.net

ARTICLE 1: Purpose

These "general terms of use" are intended to provide the legal framework for the use of the Billetix.net website and its services, jointly owned and jointly developed by Alexandre NICOLAS and Gilles FORBEAUX-REBOLI.

This contract is concluded between:

Gilles FORBEAUX-REBOLI, hereinafter referred to as "the Publisher",

Any individual or legal entity wishing to access the site and its services, hereinafter referred to as the "Primary User". The Primary User is the one who uses and pays for the Billetix.net services.

Any individual or legal entity wishing to access the site and its services, hereinafter referred to as "the User". The User is the one who uses the Billetix.net services.

The general terms of use must be accepted by all Primary Users and Users, and their access to the site constitutes acceptance of these terms.

In the event that Gilles FORBEAUX-REBOLI is unable to attend, he will be replaced by Alexandre NICOLAS.

ARTICLE 2: Legal Notices

The website Billetix.net is published by the companies Gilles FORBEAUX-REBOLI, Sole Proprietorship, whose registered office is located at 8 Ruelle des Navets – 95320 Saint Leu la Forêt - France, and by Alexandre NICOLAS, Sole Proprietorship, whose registered office is located at 4 ter Place de l'Église – 78125 Saint Hilarion - France.

The company is represented by Gilles FORBEAUX-REBOLI and in case of impediment by Alexandre NICOLAS.

ARTICLE 3: Access to services

The primary user and the user of the Billetix.net website have access to the following services:

Full web access control application.

- Not associated with a room management program.
- No server to manage.
- Nothing to install.
- Can scan IDs without a network connection.
- Tree structure: Institution, Places, Events, Representations.

- Entrance-Exit.
- Multi-passage.
- Retrieves identifiers to scan from multiple sources.
- Automatic updating of sources.
- Statistical and fiscal statements.

Any user with internet access can freely access the site from anywhere. The costs incurred by the user to access the site (internet connection, computer equipment, etc.) are not the responsibility of the publisher.

The above services are accessible to the Main User only if he/she is identified using his/her login ID provided by the Publisher (request it by email to gilles@forbeaux-reboli.fr) or by Users created by the Main User.

The website and its various services may be interrupted or suspended by the Publisher , particularly for maintenance, without prior notice or justification. As there is an offline mode, this interruption should not be detrimental to the user if they have correctly followed the instructions in the user guides.

ARTICLE 4: User Responsibility

The Primary User and the User are responsible for the risks associated with the use of their login ID and password.

The password of the primary user and the user must remain confidential. The Publisher accepts no responsibility in the event of password disclosure.

The Primary User and the User assume full responsibility for their use of the information and content on the Billetix.net website.

The primary user of the Billetix.net service can resell its services, and in doing so, assumes responsibility.

Any use of the service by the Primary User and by the User which directly or indirectly results in damages must be compensated to the benefit of the site.

ARTICLE 5: Publisher's Responsibility

Since a "network-free" mode exists, a service interruption should not be detrimental to the User if they have correctly followed the instructions in the user guides. Therefore, the Publisher cannot be held liable for any server or network malfunctions.

Similarly, the site cannot be held liable in cases of force majeure or unforeseeable and insurmountable actions of a third party.

The Billetix.net website is committed to implementing all necessary measures to guarantee the security and confidentiality of data. However, it does not provide a guarantee of absolute security.

The Publisher reserves the right not to guarantee the reliability of the sources, although the information published on the site is considered reliable.

ARTICLE 6: Intellectual Property

The content of the Billetix.net website (logos, texts, graphic elements, videos, etc.) is protected by copyright, under the Intellectual Property Code.

The user is fully responsible for any content they upload and agrees not to infringe upon the rights of any third party.

The website publisher reserves the right to moderate or delete content posted by users freely and at any time, without justification.

ARTICLE 7: Personal Data

The primary user must provide personal information to register on the site.

The main User's email address may be used by the Billetix.net website for various information communication, account management, and service billing; this email address will also be used for Users and institutions created by the User.

Billetix.net guarantees respect for the user's privacy, in accordance with law no. 78-17 of 6 January 1978 relating to information technology, files and freedoms.

Pursuant to Articles 39 and 40 of the Law of 6 January 1978, the User has the right to access, rectify, delete, and object to the processing of their personal data. The User may exercise this right via:

Personal information uploaded to Billetix.net by a User is done so under their own responsibility.

Access control data in our possession, whether archived or not, will be deleted 2 years after the date of the event.

ARTICLE 9: Changes to the general terms and conditions of use

The Billetix.net website reserves the right to modify the clauses of these general terms of use at any time and without justification.

ARTICLE 10: Contract Duration

This contract is for an indefinite term. The contract takes effect with respect to the user from the start of their use of the service.

ARTICLE 11: Invoicing

A monthly invoice will be issued, using the contact information provided by the Primary User. The invoice will be €22.35 excluding VAT in 2026 per pair (Primary User or User per Institution) used during the month. Use of this pair will be considered effective upon loading credentials onto a terminal during the month. This rate will be indexed to the "consumer price index for services" and will be reviewed at the beginning of each year. In the event of non-payment of invoices within three months, all Users and the Primary User of the institution will be deleted. Please note that a login cannot be active multiple times simultaneously.

If the User has a contract with a reseller, they must contact them first; the reseller will then contact Billetix.net customer service.

ARTICLE 13: Applicable Law and Jurisdiction

This contract is governed by French law.

In the event of a dispute that cannot be resolved amicably between the user and the publisher, the courts of Pontoise (France) shall have jurisdiction to settle the dispute.
